Both the Seller and the Purchaser Agree to the Following Conditions of this Agreement. Purchaser will initial items 1-11.	
1.	Seller guarantees that this kitten/cat is healthy to the best of her knowledge, and that the kitten/cat will have been to a licensed Veterinarian and have a current health certificate. The following Health Guarantee is provided: a. The Seller guarantees that this cat does not have FeLV, FIV, or FIP at the time of pickup or delivery. b. If within two years, this cat is found to have a fatal hereditary or congenital defect, the Seller will replace the cat with another kitten when the Seller receives proof of defect in the form of a complete necropsy report and full medical history from a licensed Veterinarian, providing that the Seller is still an active breeder. If the Seller replaces any kitten/cat for any reason described in this section, the Seller is not obligated to replace the exact color pattern as described above. The Seller is not obligated to replace the kitten/cat for any other reasons, other than those stated in this section.
2.	Purchaser has 72 hours to take the kitten to the vet for a health exam; if any health concerns are found, the Purchaser may return the kitten to the Seller within 72 hours with an explanation from the attending vet. No medical or travel charges will be refunded.
3.4.	During this first 72 hours the kitten should be isolated from any other pets and monitored for health, eating, litter box usage, and activity. The Seller is not responsible for any injury or illness to other pets caused by exposure to this kitten. The Purchaser agrees not to sell, lease, or give away this cat to any pet shop, breeding mill, research laboratory or similar facility, and will not give this cat to any animal shelter. If for any reason the Purchaser is unable to keep the cat, the Seller will assist with finding a new home for the kitten. Any travel expenses to return cat to Seller will not be refunded.
5.	The Purchaser agrees to provide the above mentioned cat with a safe and loving home, including adequate nutrition, shelter, grooming, and medical care from a licensed Veterinarian.
6.	The Purchaser agrees to spay/neuter kitten by 6 months of age. Registration papers will be held until copy of spay/neuter paperwork has been received from a licensed Veterinarian. Contract will be VOID if paperwork is not received by no later than one month after the kitten turns 6 months old. DATE:
7.	Due to controversy of the Feline Leukemia Vaccination (FeLV) and the FIP Vaccine, administration of these vaccines immediately negates the Seller's responsibility for the health of this kitten/cat.
8.	Due to the submissive nature of the Ragdoll Breed, the kitten/cat described above will not be declawed or allowed to roam outdoors. If declawed or allowed to roam outside, all health guarantees stated on this contract will be VOID .
9.	The Purchaser is responsible for all veterinarian/medical care and costs after the pickup or delivery date.
